

DAY 1: ITAR

This program will help you understand what ITAR is and how it may govern your defense related exports. We will go through an overview of ITAR, starting with what products can be subject to ITAR through the application and registration process. We'll then finish up with licensing and other areas of control. At the end of the program you will have an understanding of what is required and where to go for assistance. You will have a copy of the ITAR regulations and complete reference material moving forward. If your company is involved with military and defense articles and services, you don't want to miss this program.

DAY 2: HTS/SCHEDULE B

This program will help you begin to understand how to use the Harmonized Tariff System for imports and the Schedule B listing for exports. We will learn and review the 6 GRI- General Rules of Interpretation used to classify every product. We will go through instructor & CBP based sample classifications using each of the GRI's. By using the CROSS system we will show how CBP reviews binding ruling requests and what that means for your products. Many companies are exposing themselves unnecessarily reviewing bν not regularly understanding their own classifications. Importers and exporters are required to use reasonable care and due diligence in determining accurate classifications. Why not learn how to begin that process and keep your company in compliance?

- Review the types of licenses, license exemptions, and how to file them with AES.

Did you know...

- There are significant differences between EAR and ITAR guidelines. Responsibility for understanding and enforcing these guidelines rests solely with the exporter.
- ► ITAR and EAR compliance can be problematic for a global corporation because the data related to a specific type of technology may need to be transferred over the Internet or stored locally outside the United States to make business processes flow smoothly.
- Export control laws provide for substantial penalties, both civil and criminal. Failure to comply with ITAR can result in civil fines as high as \$500,000 per violation, while criminal penalties include fines of up to \$1,000,000 and 10 years imprisonment per violation. Under EAR, maximum civil fines can reach \$250,000 per violation. Criminal penalties can be as high as \$1,000,000 and 20 years imprisonment per violation.
