## DAY 1: EXPORT COMPLIANCE

#### AUTOMATED COMMERCIAL ENVIRONMENT (ACE)

Have you ever had questions on what all of the required fields mean, or been told a shipment is stuck because your paperwork is incorrect? Has your company paid for unnecessary documentation fees? Are you ready to utilize the new ACE (Automated Commercial Environment) filing system for your EEI – Electronic Export Information? In 2016, the government will be phasing out the legacy AES system for filing your EEI for exports. Knowing how to properly complete and self-file export documents can save your company from costly delays and loss of revenue.

All exporters, compliance officers, trade lawyers, intellectual property lawyers, financial service providers and accountants involved in International business, freight forwarders and logistics professionals, engineers, university officials, and anyone else who deals with military defense articles and services.
