- Session 1: Curricula comparisons in cross-cultural management
 - Description: Participants will discuss inspiring topics to be included in a cutting-edge course on cross-cultural management. Interested participants are encouraged to submit their course syllabi in advance to facilitate comparisons and mutual inspirations.
