**Tuesday, March 18, 2003. "The Changing Face of China—From Pagodas to Cell Towers"** presented by John Pearson, Vice President and Executive Director, Capital Choice Partnership, Lansing Regional Chamber of Commerce.

With China's recent admission to the World Trade Organization, the awarding of the 2008 Olympics, and the World Cup, the push is on to Westernize at warp speed.

For centuries China has stood as a leading civilization, outpacing the rest of the world in the arts and sciences. But in the first half of the 20th century, China was beset by major families, civil unrest, military defeats, and foreign occupation. After World War II, the Communists under MAO Zedong established a dictatorship that, while ensuring China's sovereignty, imposed strict controls over everyday life and cost the lives of tens of millions of people. After 1978, his successor DENG Ziaoping gradually introduced market-oriented reforms and decentralized economic decision making. Output quadrupled in the next 20 years and China now has the world's second largest GDP. Political controls remain tight even while economic controls continue to weaken.

Mr. Pearson has over thirty years experience in business assistance and economic development in Michigan from leadership positions in the private, public, and university sectors. He has held significant positions include a decade in banking in the Lansing region, serving as Manager of Field Operations for the State of Michigan's economic development unit, and positions at both Michigan State University and the University of Michigan providing consultation and technical assistance to businesses throughout Michigan and the Midwest. While at MSU he directed the Technology Transfer Center for nearly seven years, and coordinated the Economic Development Resource Center, of which the International Business Development Center was a key partner.
