### Tuesday, October 20, 2009, "Lansing's International Port of Entry and Foreign Trade Zone"- Robert F. Selig, Executive Director, Capital Region International Airport

Robert Seliq, Executive Director of the Capital Regional International Airport, will be speaking about the new economic opportunities and developments in the Lansing area in his speech, "Lansing's International Port of Entry and Foreign Trade Zone."

Lansing's Capital Region International Airport was officially declared a U.S. Port of Entry in January 2008, making Lansing a gateway for international travel and cargo.

The facility is creating many new opportunities for local businesses and enhances international trade opportunities in Lansing. Selig will speak about the new facilities and the future plans for Port Lansing, including the first international flight to Cancun scheduled in December.

Selig has served as the Executive Director of the Capital Regional International Airport since 2002. He has more than 25 years of airport experience; prior to this position, he was the Executive Director of Rickenbacker Port Authority in Columbus, Ohio. Selig has a bachelor's degree in business administration and he is an Accredited Airport Executive in the United States and Canada. He is the past president of the Great Lakes Chapter of the American Association of Airport Executives, and served four years in the United States Air Force.
