## **MSU-CIBER** increases its scope

MSU-CIBER ventured into an ambitious set of exciting events this fall. As our staff will attest, our undertakings become increasingly more ambitious every year. To help us out in our endeavors, we have added several new graduate students to the MSU-CIBER Team (see picture below), and we have also increased our staff by one.

Ronda Bunnell joined us in August as Office Assistant. The Office Assistant position was previously rotated among two or three students. As the MSU-CIBER team grew, we realized the importance of having consistency in the Office Assistant position, both from our side and to the liking of our many visitors. Ms. Bunnell came very highly recommended from one of the Administrators within the Broad College. She is the friendly voice you will reach when calling MSU-CIBER (517-353-4336).

As the popularity of our IT activities grew, we found ourselves wanting to do more and more. For example, our web portal, globalEDGE (http://globalEDGE.msu.edu), reached 1.8 million hits in October 2002. We feel fortunate that MSU-CIBER has managed to build a loyal community of people interested in international business issues.

Regarding study abroad activities, "Michigan State University has more students

studying around the globe than any other U.S. school...MSU offers nearly 200 study programs in about 60 countries"... MSU's number one ranking will make a good selling point for the university," Kathleen Fairfax, MSU Study Abroad Director, said (Lansing State Journal, November 18, 2002). MSU-CIBER coordinates all study abroad activities and student scholarships for the Broad College. For example, recently, Elvin C. Lashbrooke, Jr., our Study Abroad Director, raised \$18,000 from the Alcoa Foundation to support the Broad College's study abroad activities. MSU-CIBER granted more than 70 student scholarships ranging from \$500-\$1,000 per student last year.

Regarding research activities, MSU-CIBER maintains an extremely active agenda. A recent addition to our projects is a three-year \$250,000 grant provided by the National Science Foundation titled "Internet Disintermediation of Food Delivery—Spanning the Last Mile" Kenneth Boyer and Tomas Hult are co-Principal Investigators). This project examines online grocers in Canada, United Kingdom, and the U.S.

# The Euro Has Arrived: What is its Future?

The first of this academic year's International Business Forum was held on Tuesday, September 10th at the Michigan Athletic Club (MAC) in East Lansing, Michigan. The speaker, Dr. Carl Liedholm from MSU Department of Economics, presented "The Euro Has Arrived: What is it's Future?" Twelve European countries replaced their national currencies with

a single European currency called "The Euro." Dr. Liedholm outlined the positives and negatives associated with the new currency and talked about future trends. The prevailing view at the moment is that the Euro will continue to strengthen over the next year. The Euro definitely makes travel throughout countries that participate easier.

### **Overcoming Export Barriers: How the U.S.** Department of Commerce, U.S. **Commercial Service Helps Companies Increase Their Inter**national Sales

Richard Corson from the Pontiac U.S. Export Assistance Center of the U.S. Department of Commerce was the guest speaker at the October 8th International Business Forum. Mr. Corson explained that the agency helps Michigan companies export goods and services to countries all over the world through market research, locating agents, distributors, joint venture partners, licensees, and franchisees. There are about 200,000 Michigan jobs directly affected by export sales and roughly 30 billion dollars per year generated from Michigan products. Michigan is 4th in the country in export sales.

There are several different services available to assist companies in their quest to export; services such as market research,

# Research Presentation by Jeffery Reuer

Dr. Jeffery Reuer, Associate Professor at the Fisher College of Business at Ohio State University, gave an innovative presentation to Faculty and Doctoral Students on the way in which private firms may attempt to achieve the highest price when selling to another company. Co-authored with Jung-Chin, their paper titled, "Sequential Divestiture Through Initial Public Offerings" builds and tests a model of how firms are able to utilize an initial public offering (IPO) to better show their value to other firms that are interested in an acquisition.

Presenting to a capacity conference room, Dr. Reuer's engaging presentation style drew the interests of all present into the original paper with both practitioner and theoretical questions debated. CIBER would like to thank Dr. Reuer for sharing his most current work and stimulating ideas and interests at the business school.
